An initial virtual meeting for this topic will be held on September 17th at 3:30 p.m. During this meeting parents will provide input. A second virtual meeting will be held on October 15, 2020 to discuss updates to the Parent and Family Engagement Policy updates as discussed at the initial meeting. During the parent meeting held on September 17th and October 15th, results of the annual District Wide Parent Survey will be shared including a celebration along with a parent goal which will be to attain at least 90% of parent survey participation for the 2019-20 school year. We will increase our participation in the district Survey by reminding parents to participate during our Parent-Teacher Conferences and having school-wide incentives with our students, parents, and staff. Data will be discussed which includes the survey results. Based on survey results, we addressed the need for more involvement and used district resources such as FACES and Boys Town to reach parenting classes focused on teaching literacy at home, districtwide initiatives and Common Sense parenting classes. Training and events may be held virtually or in person depending on guidelines set forth by the state and CCSD.

School Organizational Team meetings will occur monthly as detailed under Nevada Regulation.

Involve parents in an organized, ongoing and timely way in the planning and preparation of the school performance plan, Title I Budget, and the Parent and Family Engagement Policy.
